Dear Mr. President:

As Co-Chairs of the Bipartisan Congressional Career and Technical Education (CTE) Caucus, we write to highlight the important role CTE programs play in providing millions of Americans with the opportunity to succeed in high-wage, high-demand jobs. We believe that a robust national CTE policy will help employers meet 21st Century economic demands and close the expanding skills gap in our nation.

Students enrolled in CTE programs have access to comprehensive training in fields such as nursing, agriculture, construction, cybersecurity, energy, and other disciplines that keep our nation competitive. According to the Department of Education's Office of Career, Technical, and Adult Education, approximately 12 million students participated in secondary and postsecondary CTE programs during the 2014-2015 school years. While the rate of participation is encouraging, funding for the Carl D. Perkins Career and Technical Education Act (Perkins) has not kept pace with demand, and states are reporting high numbers of students being placed on waiting lists for CTE courses. We believe each of these cases is a missed opportunity to expand the American workforce.

Despite the well-documented need for CTE funding, almost half of states still receive grant allocations for programming at or below 1998 levels. Increasing funding levels will help American workers succeed across numerous disciplines and sectors, especially in the skilled trades. Furthermore, if we are to embark upon a new era of American manufacturing and improved infrastructure, we will need a qualified and well-trained workforce to fill those positions. Today, more than one million positions remain open in the trade, transportation, and utilities sectors-and an additional 315,000 manufacturing positions are currently unfilled.

Despite these challenges, improving our nation's CTE programs is supported on a bipartisan basis in the House of Representatives. Last year, we introduced H.R. 5587, the Strengthening Career and Technical Education for the 21st Century Act. This bill passed the House by an overwhelming vote of 405-5. While the Senate did not take action on the legislation last Congress, we are now in a position to readdress the issue in the 115th Congress.

Just this week, the House Committee on Education and the Workforce held a hearing, "*Providing More Students with a Pathway to Success by Strengthening Career and Technical Education.*" During the hearing, stakeholders shared their unique perspectives on the value of CTE. Improving our economy requires us to harness the power of a skilled workforce.




